The Case for a National Public Inquiry Into The Causes and Frequency of Violence Against and Disappearances of Aboriginal Women in Canada – Marilyn McGonigal



On February 13, 2013, in Question Period in Parliament, NDP MPs Hon. Thomas Mulcair and Niki Ashton called for a national public inquiry into the murders and disappearances of Aboriginal women in Canada. This was triggered by the Human Rights Watch Report released that day calling for an investigation into the grossly disproportionate incidence of murders and disappearances of indigenous women as compared to all Canadian

women as well as serious revelations of allegations of RCMP members abusing indigenous women in Northern British Columbia. In the exchange, the government resisted the idea of an Inquiry apparently preferring to treat the matter as a police complaint to be referred to their complaint processes. The report in fact explains why indigenous women do not report police misconduct to the police! Simply put, they are afraid to! (See References for HRW Report.)

The next day Liberal MP Carolyn Bennett called for "a special committee (to) be appointed, with the mandate to conduct hearings on the critical matter of missing and murdered Indigenous women and girls in Canada, and to propose solutions to address the root causes of violence against Indigenous women across the country". This motion for a Parliamentary Committee was passed by all parties. It was stated that this committee was not intended to replace a Public Inquiry but to investigate and also to help determine the need for one. The Inquiry's all-party participants are now selected and are to report to Parliament in February, 2014. (See Hansard Debates, February 13-14, 2013.)

Prime Minister Harper has not addressed the issue of missing Aboriginal women and cannot resolve this issue with his usual 'law and order' philosophy or any effective plan until the following fundamental questions are addressed:

- Who are the missing women? Where do they come from? What were their circumstances?
- Why are so many indigenous women living in Canada vulnerable to becoming murdered or missing women?

- Why hasn't more been done to find the women, solve the crimes and prosecute perpetrators?
- What are the factors that tend to exacerbate the vulnerability of Aboriginal women? and
- What should be done to prevent or solve disappearances and provide adequate safety and security for indigenous women at risk?

The only step taken so far by the PM was to remove the most effective method yet deployed to begin the investigation. That tool identified hundreds of missing women in a program designed by the Native Women's Association of Canada (NWAC) and funded for five years by the previous (Liberal) ruling party with \$5 million. Upon cancelling this highly successful 'Sisters in Spirit' program in 2010 in which nearly 600 missing or murdered aboriginal women and their stories were documented, \$10 million was allocated to the RCMP for its missing persons files. This was said to replace the NWAC missing and murdered aboriginal women investigation, placing responsibility back firmly with the police. Recent reports indicate that whatever the RCMP intends to do on this file with double the money is not up and running yet. RCMP have so far reportedly gathered or

confirmed only a fraction of the number of missing indigenous women cases NWAC identified.

The suspicion is that this issue was supposed to disappear, like the missing women, without a trace! The rising numbers uncovered by Sisters in Spirit were truly an embarrassing issue for the government; it garnered heavy press and raised too many questions. NWAC was obliged under the terms of its reduced continuing funding to cease using the name 'Sisters in Spirit' (which had become almost household words) and to cease collecting the names. What does this tell you?

The Manitoba Coalition on Missing and Murdered Aboriginal Women (MMAW), Aka 'Indigenous' women (MMIW), a committee of the Manitoba Assembly of First Nations, continues its efforts to solve their missing and murdered women cases, to support families, to conduct search, rescue or recovery missions when someone goes missing and to hold vigils and services to support families and their communities. Official formal support for their efforts is lacking in that they lack proper equipment and safety gear for searches, and perhaps could hamper investigations despite sincere efforts of both police and families to find, rescue or recover loved ones. Family and friends getting involved is the most natural response of a caring community and is commonly part of organized searches for missing loved ones. By all means police expertise and resources are essential to solving missing persons cases. Rather than discourage appropriate family participation, cooperative solutions must be found in the interests of all concerned, most of all the missing women.

Not surprisingly, it was without consultation or agreement with the aboriginal communities, particularly the women

involved and knowledgeable that Sisters in Spirit was discontinued. Women continue to suffer violence and disappear from their communities. AMC and the Coalition are calling for a National Public Inquiry which will require cooperation with all our governments and every police force. It is hoped the Parliamentary Inquiry will move this in the right direction – toward solutions or a Public Inquiry.

The Royal Commission on the Status of Women, 1970, is still a landmark document for change for women in Canada. The Report of the Aboriginal Justice Inquiry of Manitoba (The Justice System and Aboriginal People), 1991, regarding the deaths of Helen Betty Osborne and J. J. Harper, revealed systemic injustices and led to changes in the Justice System that would not have happened without it. The travesty of murdered and missing Aboriginal women deserves no less than a Public Inquiry or a Royal Commission if lives are to be saved and further tragedies prevented. In 2013 is it not time to pay the same attention to the most serious issue facing Aboriginal women and their families?

United Nations Commission on the Status of Women – 57th session 852/ 784 735 Oral Statement, March 14, 2013

Read by Linda MacDonald on behalf of the Canadian Federation of University Women (CFUW) and National Council of Women Canada (NCWC)

Thank you for this opportunity to appear before you. Many member states have reported progress in their efforts to end violence against women and girls, including a good number that have developed national action plans or strategies. However, many of these plans and strategies are not comprehensive or coordinated and are lacking sufficient human and financial resources to ensure their success. Still, there are several Member States who have yet to develop comprehensive and holistic national action plans, including our own country, Canada.

It is clear from what we have heard during this session, that much more must be done in all Member States to strengthen and enforce legal frameworks, improve access to justice, expand the collection of sex-disaggregated data, and most importantly enhance prevention efforts by addressing poverty, gender discrimination and inequality,

Therefore, we wish to express our support for the recommendations presented in the Secretary-General's reports on *The Prevention of Violence against Women and Girls* and *Multisectoral Services and Responses for Women and Girls Subjected to Violence*. In particular, we wish to join in calling on all Member States to adopt and implement coordinated, comprehensive, and adequately resourced, multi-sectoral national action plans as means of preventing and responding to the continuum of violence against women and girls. In addition to the recommendations found in the Secretary General's reports, we urge member states to include:

- Distinct strategies to prevent and respond to all forms of violence, including torture by non-state actors and enforced prostitution, which are not specifically mentioned in the Secretary General's reports:
- Access to mental health programming and services for survivors and perpetrators of violence:
- Access to safe, accessible and affordable housing to ensure that women and girls are better able to avoid and escape violent living situations;

- Among the strategies to prevent and address violence against women in disproportionately affected communities, include women/persons who are lesbian, bisexual, transgendered, transsexual and/or queer. The Secretary General's reports do not specifically mention this community.
- Ratification and implementation of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), as part of the strategies to end violence against Indigenous women. In Canada, a disproportionate number of Indigenous women and girls have suffered violence, gone missing, or been murdered over the past three decades. Much of this violence is a reflection of the underlying conditions of poverty, racism and colonial history; the full implementation of the UNDRIP is an integral part of the solution.

Finally, we further urge Member States to:

- Make the elimination of violence against women a priority for international development programming and assistance, including contributing to the UN Trust Fund in Support of Actions to Eliminate Violence against Women;
- Implement and provide action plans for UN Security Council Resolution 1325 and related resolutions on women, peace and security in conflict-affected settings.

In closing we commend Secretary-General, Ban Ki-Moon for bringing together governments, the UN system and key stakeholders to address violence against women and girls through the UNiTE to End Violence against Women campaign. The launch of the Secretary-General's 2009 database on violence against women has helped Member States and civil society advocates to share information, assess and respond to the global epidemic of violence against women and girls. We urge the United Nations will continue to play a leadership role through this important campaign and other initiatives beyond 2015.

Blow to the Early Learning and Child Care Workforce - Maxine Balbon

The Child Care Human Resources Sector Council closes due to funding cut.

The Child Care Human Resource Sector Council is a pan-Canadian organization dedicated to moving forward on human resources issues in the child care sector. It was formally established in 2003 and brought together National partners and other sector representatives to help develop a confident, knowledgeable, skilled and respected workforce valued for its contribution to early childhood education and care.



As of March 2013, sector councils will no longer receive operating funds from the federal government (Human Resource Skills Development Sector Council Program). As it is not possible to continue the CCHRSC without compromising the standards and calibre of work produced, the CCHRSC Board has made the difficult decision to dissolve the organization. This is a great loss for early learning and child care in Canada. The CCHRSC was the hub for information on HR issues in Early Childhood Education, most recently the revised Occupational Standards, and the void will be felt across Canada. The *You Bet We Still Care* survey was conducted by the CCHRSC in 2012 in order to gather data on the ECEC workforce. Survey findings were helpful to develop recommendations to improve HR practices. The council's work contributed to increased recognition of the ECEC workforce and its critical importance to providing quality programs to children and their families.

"THE PRICE IS WRONG! " Awareness campaign on Food (In)Security in the North – Gisele Saurette-Roch

Given that Food security has been an issue with which Councils of Women have been struggling over the years, I thought members would be interested in this new campaign I became aware of on April 1^{st-}this April Fool's Day. I only wish it were a joke!

"THE PRICE IS WRONG" GAME SHOW was hosted at Neechi Commons at lunch-time on April 1st, hosted by a newly formed group by the same name. Their e-mail is: nonviolentsocialchange@gmail.com. They had prepared a variety of baskets of food presented by a lovely gowned hostess. A debonair mustached host asked 3 pairs of contestants how much they believed the food basket to cost up North, for example, on reserves. rounds, the audience heard testimonials from former Northern residents as to their personal struggles to feed themselves and their children. Tina Keeper was one of the guest speakers who challenged audience members to write their federal and provincial elected representatives to do something to make food more affordable for families living in the North and in remote areas. "It is time to declare the right to affordable food as a basic human right. How is it alcohol is relatively the same price all over the province? Is food not more important than alcohol for families?"

A comparison of the food baskets with the Southern and Northern values the items can be bought for follows. I personally would find it impossible to feed my children healthy food at the prices paid in the North.

Réseau Action Femmes Marches On - Blandine Pascale Ngo Tona

March was a very busy month for the volunteer board. Of course the International Women's Day was the focus of considerable time and energy. After a hiatus of two years, the board members decided to resume the Réseau action femmes Prix Réseau Awards Bunch celebrating the achievements of francophone women who have made a significant contribution to the francophone community.

The recipients of this 23rd edition of the Prix Réseau included Sophie Gaulin, the editor of the weekly newspaper, La Liberté, which is celebrating its 100 anniversary. The weekly is a jewel of the francophone community which always improving, initiating new partnerships and projects, meriting the team several national awards every year. Bintou Sacko, a Malian newcomer herself, has headed Accueil francophone, the francophone "Welcome Place" for nearly 10 years. She is also a great innovator, providing a broad range of services to the clients to promote the newcomers' integration into our community. She too nurtures many partnerships as a young volunteer at the Entre-temps des franco-manitobaines, the second stage shelter for her generosity and commitment to the organization and its clients. A novelty for us this year was the nomination of a group as a recipient. The fourth award was given to le Groupe des femmes francophones du Centre de ressources pour familles militaires. Over twenty members of the group attended, with their partners and their children, they were so moved to be recognized. It was a bittersweet moment given they were notified of the imminent closing of this particular resource centre for military families among others across the country. The community was very generous in donating funding to make it a memorable event. We decided to promote the NCWC Celebrating Women series by featuring the prints for sale.

Another initiative that we featured was the first Réseau action femmes Writing Contest for girls from grades 9-12. The texts submitted on the theme "What is the role of

young francophone women in 2013?" were very moving, such that we will put nine honorary mentions on our website and potentially publish them. They reflected the diversity of young women in Manitoba today- newcomers, urban and rural young women from across the province. The winners were Anie Brémault, 14, from Labroquerie (MB), Véronica Lilke,17, also from Labroquerie and Maryse Goli, 16, from Windsor Park Collegiate. We are committed to pursuing this initiative.

Réseau action femmes was also one of the four community organizations, along with Accueil Francophone. ETFM - L'Entre-temps des francomanitobaines, Centre de santé, who organized a special celebration of International Women's Day for newcomer women and their families. The program included three presentations on themes promoting "Family Harmony" The first was Catherine Biaya originally from the Congo, who presented the concept of "Life-mapping" showing how we make decisions to take us closer to our goals rather than divert us from our hopes and dreams, recommending that we do well to take on a learner approach to life versus a judger/blamer attitude. Next Stephanie Rouet from ETFM talked about everyone's right to safe environment and provided a list of resources available to all who live in Manitoba. The third presentation by France Adam was on relaxation techniques which are useful to use by one and all. We were entertained by two groups of young African dancers after a wonderful meal. All these young people and the male partners also benefitted from the information to enhance family harmony, for a total of 68 guests.

Réseau action femmes continues to feature a monthly column in La Liberté as well as an hour program at CKXL Envol 91 the francophone community radio, the first Tuesday of the month from 10-11 am. RAF is proud to be involved with numerous partnerships on a variety of projects. Please stay tuned.

Marie Bodnar will be graduating from the University of Winnipeg in Fall 2013 with her degree in Human Rights. In 2010 and 2012 she travelled with Christian Peacemaker Teams to the West Bank, and Iraqi- Kurdistan to job shadow full time team members, meet local organizations whose focus is on nonviolent social change and to take part in daily actions meant to undo oppression and racism. While in these areas, Marie participated in demonstrations and press conferences that highlighted injustices common in those areas such as housing demolitions, land rights and security issues.


