- 1.) Carol Hiscock, Chair, called the meeting to order at 10:20 a.m. and welcomed all to the 2019 PCWM AGM.

Active members have consisted of Bonnie Siemens- Vice President, Monika Feist-Resolutions, Daria Jorquera Palmer- Membership, Nubia Duran- Treasurer, Sandra Kloss and Arlene Jones representing CWW, and myself as President. My thanks to each for their leadership, commitment, and good humour!

Earlier in the year we continued our process review and reorganization in the office within the Clearinghouse at 825 Sherbrook. In addition, planning for the National meetings being hosted in Winnipeg, and for our annual major community gala event "Celebrating Women" was in full swing.

### FUNDRAISING REPORT

Our major fundraising event continues to be the annual **Celebrating Women Gala**, this year in its 13<sup>th</sup> year, with over 125 persons attending the evening event held at the Viscount Gort Hotel in Winnipeg. This year, delegates to the National Council of Women of Canada 126th Annual General Meeting being held in Winnipeg were invited to attend and many enjoyed the gala.

The Celebrating Women Gala is the "signature" event for PCWM and honours women nominated by council federates and a federate organization. Pam Roz, local radio 103 personality emceed the evening. There was entertainment by the Colleen Morrison Jazz Trio, a Rainbow Auction, delicious refreshments and lots of great networking. Greetings were received by the PCWM Patroness, The Honourable Janice Filmon, Lt. Governor of Manitoba, the Honourable Rochelle Squires, Minister for the Status of Women for the Manitoba Government and His Honour Brian Bowman, Mayor of Winnipeg sent greetings. Carol Hiscock, President of the PCWM presented the awards.

The **Celebrating Women Award** recognizes women within our membership who have a history of making a difference within their communities. Throughout history women, women's work and women's achievements often go unacknowledged. Celebrating Women is the Provincial Council of Women of Manitoba's way of showcasing the diverse ways that women impact the communities and people around them. Funds raised support the work of PCWM including programs, education, research, advocacy and developing briefs to the provincial government.

The three individuals honoured this year were:

**Susan Hancharyk** - nominated by the Council of Women of Winnipeg **Gerri Prymak** - nominated by Women Healing for Change 3 **Dr. Lynn Scruby** - nominated by Women's Health Research Foundation

We also presented the "Not Afraid to Get Your Hands Dirty Award", which was established in 2013 by UNPAC (United Nations Platform for Action Committee, Manitoba) to honour the long-time service of their Executive Director, Jennifer De Groot. UNPAC provided leadership to the province following the 1995 United Nations Conference on Women in Beijing, with a particular focus on women's economic literacy

The "Not Afraid to Get My Hands Dirty" award is intended for a Manitoba woman/girl who has recently demonstrated a creative activist response to an identified injustice, in an attempt to bring about social or political change for women.

Five amazing women brought the issues faced by Manitoba young people affected by the social protection system to the world's attention through a panel presentation at the United Nation's Commission on the Status of Women in the spring of 2019. Their collective action raised awareness, offered direction for positive change, and challenged the assumptions of the powerful. The diversity among them in background, story, and perspective is the hopeful face of today and of the future.

#### NCWC AGM Convention – June 13 – 19, 2019

The Provincial Council of Women and the Council of Women of Women jointly hosted the 126<sup>th</sup> Annual General Meeting of National Council of Women of Canada's AGM at the Viscount Gort here in Winnipeg. The then President, Sandra Cohen Rose attended along with delegates from all across Canada to discuss issues and resolutions revolving around key issues in our communities today.

The planning committee consisted of Carol Hiscock, Arlene Draffin Jones, Maxine Balbon, Shirley Walker, Susan Hancharyk, Sandra Kloos, Trish Masniuk, Mary Scott, Randi Su Gage, Daria Jorquera Palmer, Kelly-Ann Stevenson and Monika Feist, although so many others assisted before, during and after the event to make it a successful conference, along with the support and guidance of the NCWC Board.

This committee worked extraordinarily hard to ensure that the event was well orchestrated, and each committee member was responsible for certain events through the five day event, starting with a tour of the Canadian Human Rights Museum, to a grand celebration of Winnipeg Council's 125<sup>th</sup> year on the Thursday evening at a Welcoming Reception, with all the pomp and ceremony so deserved.

Friday and Saturday were dedicated to the plenary sessions to handle business and the resolutions brought forward to the AGM.

The NCWC Development Organization had a luncheon on the Friday, where a video provided by the Elizabeth Fry Society was featured which focused on women in incarceration and the justice system.

And, on Friday night, the PCWM held their traditional Celebrating Women Gala celebration, this being the 13<sup>th</sup> anniversary, honouring women in the community and to recognize their work over the years on the many issues facing women today. It was an exciting event and enjoyed by all who attended which included many of the delegates from the NCWC AGM.

On Saturday, the luncheon was hosted by the NCWC Education Fund organization, organized by Maxine Balbon and Gracia Janes focusing on the theme of poverty, and the barriers and solutions to income and housing as experienced by rural communities.

The panel discussion was emceed by Barbara Bowes, and featured Susan Bater, Chief Deborah Smith, Denise Joss and Elaine Biggs. A truly information and uplifting presentation.

Saturday night was a gala event held at the Viscount Gort and organized in exemplary fashion by Mary Scott and Randi Su Gage, with the program theme being "Fighting the Good Fight: The Winnipeg Strike of 1919" presented by Molly McCracken. This was the  $100^{\rm th}$  anniversary of this strike, and it was an magical evening which included Dawn Lavand with an Honouring Song, and the induction of the NCWC Executive for the upcoming term.

Before the conference was done, the assembly decided to set a course for the next two years in which we will dedicate our work, which will be listening and learning from the recommendations and themes of the report of the Commission on Murdered and Missing Indigenous Women and Girls. Chief Connie Big Eagle, Chair of the Women's Council of the Assembly of First Nations, has offered the assistance of her Council in developing programming in this area. They were very pleased our membership wishes to walk with them on the journey to Truth and Reconciliation and to continue the struggle to eliminate violence against all women. At the 2019 AGM, we worked together; we celebrated together, and at the end, we left with a sense of renewal and recommitment to continue our work.
